**1. USDA Policy Memo CACFP 01-2011 Eligibility of Expanded Learning Time Programs for Afterschool Snack Service in NSLP and CACFP**

This memorandum clarifies eligibility requirements for afterschool programs for the afterschool snack components of the National School Lunch Program (NSLP) and Child and Adult Care Food Program (CACFP), with particular emphasis on whether certain expanded day learning programs are eligible to operate the afterschool snack service.

**2. CACFP CNP web Claims by Site and Claim Revisions**

As was discussed at the annual training, starting with October 2010 claim you will be submitting the meal counts under each site vs. at the sponsor level for all programs except the family day care homes. Please use the enclosed documents (CACFP CNP web Claims by Site and CACFP CNP web Claim Revisions) to assist you in filing your FY2011 claims for reimbursement.
